# Description of WP2

A roundtable with representatives of all Ukrainian partners “Challenges for Universities and Communities: the Role and Response of the Third Mission Offices at Ukrainian Universities” – national level challenges the state authorities have on fostering the cooperation between the Universities and Communities – the problem of public management.

Capacity-building training for UNICOM centres at Ukrainian partner HEIs on macro-societal challenges (resilience and social cohesion, economic sustainable growth, green deal, digitalization) and capacity-building:

1 EU university is responsible for 1 intensive training on 1 macro-societal challenge, 5 days, blended learning, 200 hours, mobilities from EU to Ukraine, intra-Ukrainian mobilities, using the existing profiles of Ukrainian Partner in the selected area, which will form 5 working groups specialized (1) on Resilience and Social Cohesion, (2) Economic Sustainable Growth, (3) Green Deal and (4) Digitalization, (5) Public Health.

A capacity-building training on the third mission of Universities, to be conducted in Ukraine.

Design and reach-out of the training on the third mission of the Universities.
